Bulky Trash Pick-Up – September 17

The next combined Bulky Waste and E-Waste collection day of 2016 is scheduled for Saturday, September 17. Items should be placed at curbside no later than 6:00 a.m. Items placed at the curb after 6:00 a.m. will not be taken.

Bulky trash is defined as: furniture; appliances; water heaters; refrigerators (compressors removed); stoves; sinks; lawn furniture; doors; windows; screens; mattresses; beds and rugs. E-waste such as TVs, DVDs players, radios, printers, computer monitors and microwave ovens also will be accepted. Unacceptable items include: construction waste; green waste; and hazardous waste such as cleaning products, automotive fluids and pool chemicals. You may contact the waste hauler directly if you have construction waste and are in need of a temporary debris container.

SCAMS –

IRS scam calls continue in PVE with one resident receiving 4 calls a week and asked to call 256-343-3761.

Area cities are receiving reports of citizens getting calls from people claiming to be the IRS or other Government Agency. The suspect will call and tell the victim that they owe money to the Government and must make immediate payment with a prepaid card or wire transfer. **Most recently we have had the caller ask to make payment via an iTunes Cards.** These callers are very convincing and will use threats of jail time. If you are to receive a call similar to this **hang up and do not send any payment.**

Disaster Planning Tools Available to PVE Residents

During major disasters, it is not uncommon for emergency personnel to be overwhelmed by a number of concurrent calls for service. As a result, it is imperative that each household take proactive steps to be prepared in the event of a major disaster. Emergency personnel from both the City's Police Department and from the Los Angeles County Fire Department have devised complementary plans to help increase our community's survivability. These programs are described briefly below:

Disaster District Program (DDP)

The City of PVE has developed a comprehensive community based disaster preparedness and response program known as PVE Disaster District Program (DDP). With a select group of volunteers the program is designed to increase disaster readiness and survivability at the neighborhood level during a disaster.

The program divides the City into 6 Disaster Districts, each equipped with a cache of equipment and supplies *to support community responders*. Managed by sworn Disaster Service Worker Volunteers under the City's Disaster Services Coordinator, the program integrates the resources of PVE's disaster services including area CERT members, Neighborhood Amateur Radio Team (NART), Disaster Service Workers (DSW) and the PVE Police Dept Reserve Corps.

PVE's Get Ready – Get Certified Program

Together with resident volunteers and emergency personnel, the City is pleased to announce the Get Ready – Get Certified disaster preparedness program.

The Get Ready – Get Certified program has been developed as a component of the PVE Disaster District Plan (DDP) devised to enhance your family's emergency preparedness. The program is designed to allow residents to self-certify through an easy 3-step process:

- Become informed about Disaster Preparedness and develop, and implement, a household plan using the Get Ready – Get Certified guidelines.
- Acquire and safely store adequate water and food supplies for each household member.
- Acquire and safely store emergency equipment and supplies for your household.

The City will provide the requisite sources of information to accomplish these three actions. When these three steps are complete, a one-page self-certification form demonstrates your household has completed the three step process. NART- Neighborhood Amateur Radio Team

If a severe emergency should hit our City, the ability to communicate with all departmental entities by the Emergency Operations Center at City Hall is vital. Officials might also have to contact other South Bay cities for mutual aid. Finally, there is a need for the various City and county agencies to communicate with one another. The systems that are in place to accomplish all these needs will quickly become



overwhelmed when a large-scale emergency hits. Fortunately, the City has a group of Amateur Radio Operators (Hams) who have been trained to help solve these problems. The group is called the Palos Verdes Estates Neighborhood Amateur Radio Team or PVE/NART for short. The City and Neighborhood Watch group have provided funding for the complete VHF/UHF Ham stations in City Hall and PVE Police Department Mobile Command Unit that can act as a back up Emergency Operations Center if City Hall becomes unavailable.

We have the organization and we have the equipment. However, we need more operators. If you are a licensed ham and could help, please call Community Relations Officer Marcelle Herrera at (310)378-4211. There are no dues and the demand on your time will be minimal—about 30 minutes a week after being trained on your equipment. In his State of the Union message, President Bush urged all U.S. Citizens to donate 4000 hours of volunteer work over his/her lifetime. He called it the "U S A Freedom Corps." Here is one way you can meet that challenge. Your support could make the difference if (when) a disaster hits. If you would like to help but do not have a ham license, there are classes offered locally to help you pass the FCC tests. Knowledge of Morse code is no longer necessary for some classes of license. Details will be provided if requested.



Palos Verdes Peninsula Community Emergency Response Team (PVPCERT)

The PVPCERT is a government/community resource that provides basic training in disaster preparedness necessary to help you help your family, your neighborhood, and your community in a disaster. We are a registered California Corporation and have IRS Tax Exempt status as a nonprofit entity under IRS 501 (c) (3).

- **PVPCERT is a Community Emergency Response Team that is unique to the Peninsula area.**

- **Benefits of such a team can provide for an effective first response.**
- **Members are provided continuous training.**
- **PVPCERT team members meet on a bi-monthly basis to review various scenarios dealing with natural disasters**

LA COUNTY FIRE DEPARTMENT - Ready! Set! Go! Personal Wildfire Action Plan

In a similar manner, the Los Angeles County Fire Department takes precautions to help protect you and your property from wildfire. In the event of a major wildfire, however, there will simply not be enough fire engines or firefighters to defend every home in the early stages of the incident. This reality requires you to take personal responsibility for protecting yourself, your family and your property.

The Fire Department developed the Ready! Set! Go! Personal Wildfire Action Plan to give you the tips and tools to successfully prepare for a wildfire. The Plan will give you guidance on retrofitting your home with fire-resistive features and it will help you create the necessary defensible space around your home. This publication will help you prepare your home, yourself, and your family so that you can go early; well ahead of a fast-approaching wildfire.

In Los Angeles County, wildfires are often fueled by dry vegetation and driven by hot, dry “Santa Ana” winds, making them extremely dangerous and impossible to control. However, many residents have built their homes and landscaped without fully understanding the impact that a wildfire could have on them. Few have adequately prepared their families for a quick evacuation.

It’s not a question of “if,” but “when” the next major wildfire will occur in Los Angeles County. That’s why the most important person in protecting your life and property is not the firefighter, but yourself. Through advance planning and preparation, we can all be ready for the next wildfire. 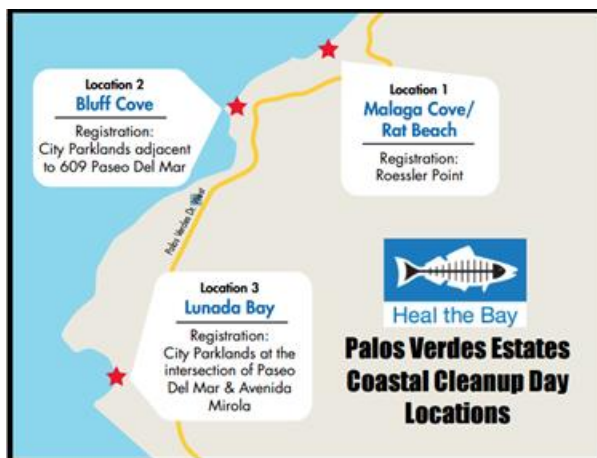
COMING EVENTS

SCAMS – DMV, IRS

An email appearing to be from Department of Motor Vehicles advises recipient that they have not responded to the automatic traffic enforcement ticket(s) listed in the email. It indicates a minimum fee of \$29 or higher will be assessed if personal service is required (meaning telephone assistance). It asks the recipient to select to either 1) Admit pay the full amount due; 2) Admit with an Explanation in writing or 3) Deny and appear for an in-person hearing. It further asks you to click on a hyperlink to locate your Ticket ****DO NOT CLICK ON THE HYPERLINK***. In this case the amount due was \$464.00

A resident reported the following: “Just listened to phony IRS call from DAVID at 1-248-702-7849. Sometimes we get these calls more than once during the day! Hope other PV residents just listen to the message and don't listen on their phones.”

And another resident stated: “My 7th IRS call came this morning at 7 AM (#6 was last night). The most recent “Call immediately” phone numbers are: 248-702-7849, 512-813-7292, and 512-813-7295.”

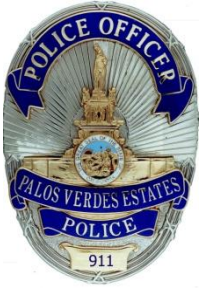

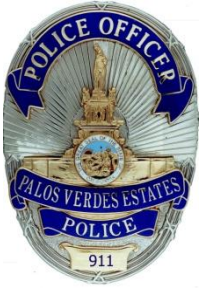
